What unaccompanied young members (14 to 18 years old) can expect from the Labour Party whilst at conference:

- We will provide a positive and welcoming environment to all young members, particularly those aged fourteen to eighteen who are unaccompanied.
- If young members need assistance during conference opening hours they should head to the Enquiries Desk or venue Reception Desk.
- If young members are unable to get to the Enquiries Desk in person they can call our Safeguarding lead, Kate Bolger on 07545 421 400 who will be happy to help.
- If young members need assistance urgently during conference, for example during a medical emergency or for any other reason, they should contact the nearest staff member and tell them what’s happening.
- If a young member or someone else is at immediate risk of harm or needs medical help they should contact the Police and/or ambulance on 999.

- Staff will provide support to young members as far as they are able to and they may direct young members to a different organisation or charity that may be better able to help them.

What we expect from unaccompanied young members (14 to 18 years old) whilst they're at conference

Do

- Be responsible and look after yourself
- Report anything or anybody that worries you to a staff member or steward
- Ask for help if you need to
- Be responsible for getting to and from Conference and other events each day
- Enjoy yourself and take part in as many activities as possible

Don't

- Put yourself in a position where you, or someone else, may come to harm
- Drink alcohol, smoke or vape
- Use language which is discriminatory towards age, disability, gender reassignment, race, religion or belief, sex, sexual orientation, marriage and civil partnership, and pregnancy and maternity
- Behave in a way that could reflect badly on the party
- Behave in a threatening, abusive or violent way in person or online

All members are expected to treat staff, volunteers and other members with courtesy and respect. Any young member who behaves in a way that puts themselves, or someone else, at risk of harm may be removed from Conference and their parent or guardian contacted to collect them and take them home. They may also be subject to Labour Party disciplinary procedures.

Any serious issues which occur outside of the conference venue should be dealt with by the Police. Anyone who believes an unaccompanied child may be in danger should immediately call 999.
